## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Floristry, green retail trade and styling expert can work at a flower store, garden centre or company in interior plantation, but he can also work as an independent designer or work for companies which also work in designing, decoration and styling living, fragile products and natural materials. There is an increasing range of assortment in this branch. Aside from floral and plantation arrangements which are an inherent part of this branch, more and more often products such as interior objects are being sold as well.

<p><b>Access to next level of education/professions</b> The Floristry, green retail trade and styling expert can develop through higher professional education in disciplines such as floristry, styling, and potentially business-related disciplines.</p>	<p><b>International agreements</b> Floristry, green retail trade and styling expert is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25445 The education and training for this qualification is offered as of 01-08-2015.</p>	

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
