The Sports and recreation worker is employed in the sectors sports and recreation. He can carry out his work in a wide variety of organisations, for example recreational enterprises such as campsites and bungalow parks, attraction parks and group accommodation facilities or in sports organisations such as fitness centres, indoor and outdoor centres and outdoor sport enterprises. He can also be employed with (semi) government organisations and healthcare organisations. The Sports and recreation worker undertakes (parts of) sports and recreation activities, accompanies guests/participants and supervises.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
