<p>The Physical chemistry analyst works in the laboratories of hospitals, blood banks, universities, diagnostic centres, inspection services, research institutes, the industry and in teaching establishments. Here, simple tests, measurements and (sometimes complex) analyses are carried out. The Physical chemistry analyst analyses chemical and physical substances and products (raw materials, semi and fully manufactured articles), to see if they meet the quality requirements. In addition, the Physical chemistry analyst checks if the analytical methods used meet the set quality and safety requirements.</p>

<p>Access to next level of education/professions Based on schooling and/or experience, development opportunities are available. Depending on personal interest, abilities and experience, the Physical chemistry analyst may advance to a specialisation within the profile, in which a deepening or broadening of the field is possible. Further development towards an executive or staff position is also possible. The Physical chemistry analyst certificate gives access to higher professional education, related or not such as in biology and/or medical laboratory research, chemical technology or as an instructor/teacher.</p>	<p>International agreements Physical chemistry analyst is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration.
