## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Draughtsman mechanical engineering generally works for middle-sized and smaller companies, which are supplying companies of semi-finished and completely finished products. He is usually employed on the departments with a drawing room, work preparation or a project agency. He draws various products or parts for them for the metal production industry, machinery construction or transport industry. The work involves both the making of new drawings and the revision of existing ones.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>            The Draughtsman mechanical engineering could be promoted to a Draughtsman designer through education or a course in one of the studies concerning metal industry.</p>	<p><b>International agreements</b>            Draughtsman mechanical engineering is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).            In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.            In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b>            The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
