## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Draughtsman mechanical installations works for an installation company or advice agency for which he draws installation drawings, installations schemes, controle schemes of mechanical installations for new buildings, expansion projects and renovation projects. It includes installations for central heating, gas installations and combustion installations, sanitary systems and drinking water systems and special installations for hospitals and industry with the corresponding control technical systems. The work involves both the making of new drawings and the revision of existing ones.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>                  The Draughtsman mechanical installations can progress in education through Draughtsman mechanical engineering or one of the installation courses.</p>	<p><b>International agreements</b>                  Draughtsman mechanical installations is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
