## 3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Loads, unloads, checks and transports cargo in a port area

- 1.1 Does preparatory work for the loading, unloading, checking and transporting of cargo
- 1.2 Carries out the loading, unloading, checking and transporting of cargo
- 1.3 Completes the loading, unloading, checking and transporting of cargo

Core task 2: Guarantees safe transport with no damage

- 2.1 Does preparatory work for securing, untying and stowing of cargo and/or vehicles
- 2.2 Stows cargo and/or secures cargo and/or vehicles or unties them
- 2.3 Completes the stowing, securing and untying of cargo and/or vehicles

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Port operations worker can work at a port company involved in loading, unloading and storing cargo. Depending on the kind of cargo, he can work at a company dealing in general goods, container transshipment, bulk goods or storing & distribution among others.

<p><b>Access to next level of education/professions</b>                  After several years of practical experience, the Port operations worker is able to operate all important equipment in the port and master all possible control functions. He can then progress to large vehicle operator such as straddle carrier driver, bridge crane operator, reach stacker driver and team leader, coordinator, supervisor or operator positions. After obtaining this qualification, the Port operations worker can transfer to the VET study programme Skilled port operations worker (level 3).</p>	<p><b>International agreements</b></p>

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
