3. PROFILE OF SKILLS AND COMPETENCES

- 1.3 Completes the loading, unloading, checking and transporting of cargo

Core task 2: Guarantees safe transport with no damage

- 2.1 Does preparatory work for securing, untying and stowing of cargo and/or vehicles
- 2.2 Stows cargo and/or secures cargo and/or vehicles or unties them
- 2.3 Completes the stowing, securing and untying of cargo and/or vehicles

Core task 3: Monitors the progress of operations at terminal

- 3.1 Monitors the progress and adjusts the implementation of the operational process
- 3.2 Is responsible for the proper use of machines, tools and materials
- 3.3 Records and reports information regarding the operational process

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Skilled worker port operations can work at a port company involved in loading, unloading and storing cargo. Depending on the kind of cargo, he can work at a company dealing in general goods, container transshipment, bulk goods or storing & distribution among others.

<p>Access to next level of education/professions After several years of work experience and the supplemental level 4 education Coordinator port operations, a Skilled worker port operations can develop to become a coordinator port operations.</p>	<p>International agreements Skilled worker port operations is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
