### 3. Profile of skills and competences

Core task 1: Carries out nautical tasks

- 1.1 Moors/casts off and docks/disengages the inland sailing vessel
- 1.2 Anchors the inland sailing vessel
- 1.3 Steers the inland sailing vessel
- 1.4 Provides instruction from the bow or stern
- 1.5 Makes the inland navigation vessel ready to sail

Core task 2: Manages cargo

- 2.1 Makes the inland navigation vessel ready for loading and/or unloading
- 2.2 Loads and unloads the inland sailing vessel
- 2.3 Monitors the cargo conditions during transport

Core task 3: Carries out tasks related to maintenance, supply and on-board quarters

- 3.1 Carries out routine maintenance work and repairs
- 3.2 Carries out mechanical maintenance and repairs
- 3.3 Stays and works on board
- 3.4 Acts by calamities
- 3.5 Takes care of housekeeping activities on board the inland navigation vessel

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Able bodied seaman inland navigation works on board an inland shipping vessel. He prepares the ship for departure, is responsible for the cargo and is involved with maintenance and supplies. His work also includes dayto-day tasks.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

### Access to next level of education/professions

After several years experience and additional training, the Able bodied seaman inland navigation can progress to a position of Skipper inland navigation by following the VET study course Skipper inland navigation. The Able bodied seaman inland navigation can also transfer laterally to positions on shore, for example at harbour storage and transhipment companies, or operating maritime engineering structures.

### International agreements

In the Netherlands, Able bodied seaman inland is a regulated profession under the European directive 2005/36/EC, amended by directive 2013/55/EU.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25509 The education and training for this qualification is offered as of 01-08-2016.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### Average duration of the education/ training leading to the certificate

2 years (3200 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

### 7. Additional information

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
