- 1.4 Constructs the wiring for electro technical installations and systems

- 2.1 Compiles, monitors and tests (complex) (sub) products for industrial systems
- 2.2 Determines position of components and route of cables for electro technical industrial systems
- 2.3 Switches on and tests electro technical industrial systems
- 2.4 Supervises and coaches mechanics and monitors the planning

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Within the technology sector, a Skilled mechanic electro technical industrial installations and systems (SMEII) can work for a company which manufactures, places, repairs, renovates, disassembles and adjusts electro technical systems. This involves installations such as general control and allocation systems, electro technical installations, facility management systems, data networks, telecommunication installations, electro orchestration systems, lightning and overpower prevention systems, (public) lighting, illuminated advertising, security systems and traffic signalling.

The SMEII can be deployed in one of the following subareas: industry, control technology, houses & utility, lightning and overpower prevention systems, (public) lighting, illuminated advertising, security systems and traffic signalling. He can work for industrial and non-industrial companies and private clients.

The SMEII works at various locations, such as houses, residential buildings, stores, industrial areas and utility buildings (such as schools, offices and hospitals).

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration.
