An Operator C works in various sectors and companies which are part of sectors such as food & recreational substances, textile & leather, paper industry, publishers & printing companies (graphic industry), oil industry, chemical industries, rubber & synthetic industries, metal industries, machine industry, electro-technology, transport equipment and furniture sectors. This means that the Operator C's context and work setting may vary strongly. He works with an automatized process, in which parts of the production process have been more or less integrated.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>            Depending on personal interest, abilities and experience, it is possible for an Operator C to develop through a higher professional education, such as Chemical technology. He can also go get a branch diploma for VAPRO D. The Operator C can also transfer to another sector within the process industry. He can also develop to a management position within the R&amp;D department.</p>	<p><b>International agreements</b>            Operator C is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).            In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.            In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>            The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
