4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Glass craftsman creates glass products and works in a glass craftsmanship company in the branch of glass industry. The Glass craftsman can work both in a studio and externally. He generally works as an independent contractor or freelancer, but he can also be employed as an independent professional. The glass products and services are supplied to private clients, companies, monument owners, church representatives, the government, artists, contractors, decorators, glaziers and glaseries.

<p>Access to next level of education/professions A Glass craftsman has several possible options in which to develop. Firstly, he can develop his trade from a creative perspective. A Glass craftsman can start up his own enterprise. If this enterprise is prosperous, it can grow and the Glass craftsman can hire staff. Aside from this, the Glass craftsman can receive further education. He can develop through art academy, fashion academy, or a higher professional Industrial formalisation education, in which he can develop in conceptual design and formalisation areas. Finally, a Glass craftsman can decide to take on extracurricular activities. Many Glass craftsmen provide courses and training in their own studio. It is also possible to teach through guest lectures. Furthermore, a Glass craftsman can take part as a professional in various advisory commissions and partnerships.</p>	<p>International agreements Glass craftsman is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
