## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Product presentation worker works in companies in the advertising, communications and presentation industry where spatial presentations are designed. Examples of companies where he can work are: window display agencies, visual merchandising agencies, retail companies with their own presentation team, large retail companies, retail chains, suppliers of window display materials or displays, design agencies that focus on retail, architectural firms, stand construction companies, brand manufacturers, retail/ project design companies, set construction companies and companies involved in 2D and 3D trends and developments. In addition, he may be assigned to do the atmosphere and theme styling for (interior) stores, for photo shoots and for events. The Product presentation worker realizes designs aimed at product presentation.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
