3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Restoration carpenter are:

- Arrange the building site and positioning of measuring poles and all kinds of casings;
- Make outdoor en indoor carpentry;
- Restore outdoor carpentry among other things as casings, doors, windows and façade cladding;
- Restore indoor carpentry among other things as wall cladding, casings, doors and staircases;
- Perform restoration works of carpentry;
- Prepare the execution of restauration works by tile-layer, bricklayer or carpenter;
- Making and positioning of (small) formwork and concrete work.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Restoration carpenter can work in various positions in the construction industry, the specialised construction industry and at specialised restoration contractors

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
