## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Junior military officer are:

Core task 1: Carries out military assignments

- 1.1 Receives an assignment and gathers together information about the operation
- 1.2 Makes ready for operation
- 1.3 Moves through the operation area
- 1.4 Organises the accommodation location
- 1.5 Carries out surveillance and inspections
- 1.6 Maintains safety in operational area
- 1.7 Regains contact with own unit
- 1.8 Takes protection measures
- 1.9 Acts in cases of incidents and calamities
- 1.10 Evaluates their actions

Core task 2: Gives instruction and training

- 2.1 Works up the unit
- 2.2 Solves acknowledged performance problems

Core task 3: Supervises and carries out coordinating tasks

- 3.1 Develops a plan for a group assignment
- 3.2 Communicates the plan to the group
- 3.3 Carries out the plan
- 3.4 Assesses the performance of the team in the assignment
- 3.5 Carries out talks with individual group members
- 3.6 Reflects on their own performance as leader

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The defense sector is part of the order and security sector. The Junior military officer can, provided she meets the security, inspection, and selection requirements work for one of the parts of defense.

<p><b>Access to next level of education/professions</b> With the certificate of Junior military officer, transfer is possible to a middle management or specialist course (qualification level 4).  The Junior military officer starts at the level of sergeant. From the rank of general sergeant he can rise to the position of sergeant first class, sergeant-major or sergeant major of cavalry and warrant officer.</p>	<p><b>International agreements</b> The profession of Junior military officer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94870 The education and training for this qualification is offered as of August 1, 2009.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
