3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Caretaker dairy cattle are:

Core task 1: Takes care of animals and the living and working surroundings

- 1.1 Feeds animals
- 1.2 Handles and takes care of animals
- 1.3 3 Monitors animals
- 1.4 Cleans and disinfects the living and working surroundings
- 1.5 Furnishes and maintains the living and working surroundings

Core task 2: Takes care of production

- 2.1 Is responsible for milk production
- 2.2 Takes care of animal product
- 2.3 Takes care of food harvesting and grazing field

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Caretaker dairy cattle works in a company that keeps animals. There are companies that keep animals for semen collection, for rearing, or for the production of animals and/or animals products. In addition, there are companies that keep animals for recreational, educational, sociocultural and/or therapeutic purposes. Finally, there are companies that keep animals for research purposes. The vocational context of Caretaker dairy cattle depends on the company system used.

Access to next level of education/professions Career opportunities for the specialization of Caretaker dairy cattle are found in rising to animal keeper or business manager, or developing activities such as agritourism and agricultural nature conservation further.	International agreements The profession of Caretaker dairy cattle is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.														
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97703 The education and training for this qualification is offered as of August 1, 2011.															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
