3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor medical laboratory technology are:

- To take or assist in taking the material to be studied from patients, such as taking blood samples and assisting with punctures;
- To prepare material independently for further study using the proper techniques;
- To study the material independently with the most common medical equipment;
- To check the operation of analyses equipment by means of control measurements;
- To critically interpret the results;
- To use, put away and administrate materials and results;
- To report on his work and the results;
- After instruction, to carry out new techniques.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Supervisor medical laboratory technology generally works in one of the laboratories connected with a hospital. Depending on the particular specialisation of the Supervisor medical laboratory technology, this may be a clinical chemical/haematology laboratory, a pathology laboratory or a microbiological laboratory. At all these laboratories the Supervisor analyses patient material (body fluids, cells or tissue) with the aim of gaining information about the disease affecting the patient or with the aim of identifying diseases at an early stage (screening). The results of his work are used by doctors for the purposes of medical treatment.

International agreements The profession of Supervisor medical laboratory technology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
