3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Mechanical contracting firm worker are:

Core task 1: Carries out mechanical contract work

Prepares the job;

Organizes own activities;

Drives machines and equipment to the work site;

Prepares work site;

Carries out mechanical work activities;

Rounds off the job.

Core task 2: Performs maintenance of the machines

Performs periodical maintenance.

The Mechanical contracting firm worker performs routine and distinct work. He/she has a customer friendly, precise and flexible attitude. He/she always works under the orders of the executive employee and is responsible for his/her own work. He operates machines for earth moving, earth treatment, farming preparation, crop preparation and harvest. He works the soil, sows and plants, and transports soil or harvest products. He maintains the equipment and machines and repairs these if necessary.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Mechanical agricultural contract worker; land consolidation contract worker; earth moving contract worker; fertilizer distribution contract worker; or contract worker in a company with a combination of activities.

| <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
