3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor forestry and nature management are:

Core task 1: Draws up development, maintenance and/or management plan

- Makes an inventory of the wishes for development, maintenance and/or management plan;
- Makes an inventory of the territory and surroundings;
- Draws up development, maintenance and/or management plan;
- Presents development, maintenance and/or development plan.

Core task 2: Takes care of the execution of the work in nature and living environment

- Draws up work plan;
- Organizes people, materials and means;
- Makes and supervises the planning;
- Supervises employees in the technical field;
- Provides information to employees and takes care of their development;
- Supervises execution budget;
- Supervises implementation of quality policy;
- Acquires;
- Carries out work;
- Delivers work.

The Supervisor forestry and nature management has a customer and public friendly attitude, is enterprising and shows initiative. He/she reports about the progress of the work to his/her superior. He/she mainly works in the organisation and work preparation of the work execution. He/she instructs employees and supervises budgets.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor forestry and nature management may work as an employee of a government organisation, such as a municipality or provincial government, a foundation or water authority, a sports association, for example for golf courses, a recreational company, a consultancy office, or a company such as a gardening company or a green space contractor. He/she can work for an organisation that owns a nature or landscape area.

He/she can also work as an independent entrepreneur (without employees).

However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
