The most important duties of a Footwear soles manufacturer/entrepreneur are:

Core task 1: Manufactures soles ready for delivery

- 1.1 Carries out preparatory work for the manufacture of soles
- 1.2 Attaches uppers using tacks
- 1.3 Attaches mouldings and evens out gel fillings
- 1.4 Attaches midsoles and outer soles
- 1.5 Attaches heels
- 1.6 Finishes off footwear

Core task 2: Starts and runs a sole-manufacturing business

- 2.1 Starts a sole-manufacturing business
- 2.2 Gives form to a sole-manufacturing business
- 2.3 Innovates the sole-manufacturing business
- 2.4 Participates in networks
- 2.5 Promotes and profiles the sole-manufacturing business
- 2.6 Monitors and is responsible for the financial situation
- 2.7 Assesses investments
- 2.8 Manages the business administration
- 2.9 Buys in articles, materials and/or raw materials
- 2.10 Is responsible for policy in the areas of quality, safety, environment and working conditions

A Footwear soles manufacturer/entrepreneur works as a self-employed footwear soles manufacturer and as a freelancer for orthopaedic footwear companies.

<p><b>Access to next level of education/professions</b> A Footwear soles manufacturer/entrepreneur can develop into various professions: footwear uppers maker/entrepreneur, last maker, and orthopaedic footwear technician. This will require additional training or education. Obtaining the diploma of Footwear soles manufacturer/entrepreneur gives access to the programme for Orthopaedic footwear technician level 4.</p>	<p><b>International agreements</b> The profession of Footwear soles manufacturer/entrepreneur is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94660 The education and training for this qualification is offered as of August 1, 2009.</p>																					

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
