3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor computer interface technology are:

- Assembly, modification and maintenance of computer systems;
- Development, modification and maintenance of control interfaces;
- Development, modification and maintenance of communication systems;
- Assembly, maintenance and control of computer operating systems and automated measuring systems.

The Supervisor computer interface technology is responsible for the execution of his set of tasks and for that he should also be able to answer to colleagues (not hierarchically). Besides, he bears a hierarchical responsibility. He checks and supervises the application of automated routines and standard procedures by others or he represents the company in the field. That responsibility concerns risks of damage to equipment and of interruption of production, planning, administration, management and development of assigned parts of the entire installation/maintenance cycles. Furthermore, he combines or devises new procedures. It concerns specialist skills and knowledge and skills and knowledge independent from the profession. Furthermore a Supervisor computer interface technology supervises employees and plans and coordinates these activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor computer interface technology is employed at automation business companies, computer hardware & software companies, telecommunication and data-communication companies, as well as network management and technical-commercial departments.

International agreements The profession of Supervisor computer interface technology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
