The most important duties of an All-round logistics worker wood trade are:

Core task 1: Receives and stores products

- 1.1 Receives, inspects and registers products
- 1.2 Unloads products and makes them ready for storage
- 1.3 Divides and keeps products
- 1.4 Keeps an inventory of the stock

Core task 2: Assembles and prepares products for transport

- 2.1 Collects and transports products
- 2.2 Carries out VAS activities
- 2.3 Makes products ready for delivery
- 2.4 Delivers products at external means of transport

Core task 3: Guides and manages

- 3.1 Instructs and guides working duties
- 3.2 Monitors the progress of the logistic process

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round logistics worker wood trade works in the wood trade, where wood and sheet material are imported, stored, processed, and traded.

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. <p><b>Access to next level of education/professions</b> The most logical step for the All-round logistics worker wood trade is to become an assistant manager logistics wood trade. Another possibility is to broaden the working area by switching to an adjacent sector with logistic activities such as those in warehouses and in storage and transfer. With the certificate of professional training, transfer is possible to a middle management or specialist course (qualification level 4).</p>	<p><b>International agreements</b> The profession of All-round logistics worker wood trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95755 The education and training for this qualification is offered as of August 1, 2012.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
