3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Aviation service provider are:

Core task 1: Offers service to (international) passengers/guests

- 1.1 Informs and assists passenger/guest
- 1.2 Ensures safety and compliance with rules
- 1.3 Cooperates in an international team

Core task 2: Offers guidance to (international) passengers/guests at an airport

- 2.1 Takes care of passengers and luggage
- 2.2 Supervises boarding and disembarking of passengers from the ground
- 2.3 Takes care of special luggage

Core task 3: Offers guidance to (international) passengers inside the aeroplane

- 3.1 Prepares for the flight
- 3.2 Supervises during the boarding and disembarking process in the aircraft
- 3.3 Supervises and takes care of passengers during the flight
- 3.4 Completes the cabin activities

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An Aviation service provider works at airline, airport or supporting company in the aviation sector. Depending on her tasks the Aviation service provider works at various location at the airport as a passage crewmember (for example in the departure hall, arrival hall or the gate) or in the aeroplane as a cabin crewmember.

<p>Access to next level of education/professions An Aviation service provider can eventually provide coordinating tasks. It is possible to develop to supervising functions within aviation service. Aside from that, the Aviation service provider can also be placed in companies outside of the aviation service, due to her knowledge in modern foreign languages her highlevelled hospitality and high resistance against stress. These can be companies where complex service tasks can be done. After achieving this qualification, the Aviation service provider can develop through various higher professional educations, especially lingual educations such as a teacher course or educations in the communication, tourism and event organisation areas.</p>	<p>International agreements The profession of Aviation service provider is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
