PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Coordinator port operations are:

Core task 1: Carries out activities in connection with the commercial policy of the organisation

- 1.1 Coordinates the loading, unloading and relocation of goods in the port
- 1.2 Supervises the colleagues by the loading, unloading and relocation of goods in the port
- 1.3 Supervises colleagues operating work vehicles
- 1.4 Is responsible for the adequate use of work vehicles and materials
- 1.5 Loads goods in the port
- 1.6 Unloads goods in the port
- 1.7 Relocates goods in the port
- 1.8 Identifies problems and dangerous situations
- 1.9 Inspects and reports damages to the cargo
- 1.10 Completes the loading, unloading and relocation of goods in the port

Core task 2: Coordinates and assists in the securing and releasing of goods in and around the vessel

- 2.1 Coordinates and assists in the securing and releasing of goods in and around the vessel
- 2.2 Supervises the colleagues by the securing and releasing of goods in and around the vessel
- 2.3 Is responsible for the maintenance of hand tools and materials
- 2.4 Secures goods in and around the vessel
- 2.5 Releases goods in and around the vessel
- 2.6 Identifies problems and dangerous situations
- 2.7 Completes the securing and releasing of goods in and around the vessel

Core task 3: Coordinates and assists in carrying out inspections

- 3.1 Coordinates the implementation of inspections in the port
- 3.2 Supervises the colleagues in the implementation of inspections in the port
- 3.3 Inspects incoming and outgoing cargo
- 3.4 Reports data concerning the cargo file
- Identifies problems and dangerous situations
- Tunes the progress to the departmental planning and the client

Core task 4: Provides support to people and measures taken

Access to next level of education/professions

After additional training and/or proven competencies, the Coordinator port operations can rise to higher managerial position such as the position of manager port operations and terminal manager. After this qualification, the coordinator port operations can be promoted to the intermediate vocational education programme for Manager port operations (level 4).

International agreements

The profession of Coordinator port operations is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC. amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93120 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
