#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Pavement worker are:

Core task 1: Carries out basic ground, waterway and road work

1.1 Sets up and maintains temporary traffic signs

1.2 Sets up and maintains work terrain

1.3 Takes measurements

1.4 Performs preparatory work

1.5 Lays hard surfaces

1.6 Puts work areas into agreed condition

Core task 2: Carries out road work

2.1 Inspects foundations and lays surfaces

2.2 (Re) adjusts/ roadwork/ installs / repairs tires and cess-pits/ manholes and drain covers/ drains/ pavements

2.3 Removes and/or places road furnishings

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Pavement worker generally works on streets and pavements but also in gardens, industrial estates, parks and playgrounds. He works in public areas such as shopping centres and residential districts.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
