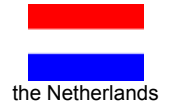

<b>4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE</b>
<p>The majority of the Pedicurists practises their profession as a sole proprietor. She has her own company or works ambulatory. The Pedicurist could be employed by a company. Possible work environments are: pedicure company, beauty farm, medical pedicure centre, health care centre, pharmacy or perfumery.</p>

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Qualification level 3 of the Dutch VET qualification structure</p> <p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. <p><b>Access to next level of education/professions</b></p> <p>The Pedicurist could within the field of pedicure develop further concerning complementary and specialist treatments and by working in a multidisciplinary foot team. A promotion to the position of a medical pedicurist is a likely possibility. Further promotion is in the field of: educational instructor, assessor, manager and also as a sole proprietor. Further development by means of additional education is possible through transfer to qualification Medical pedicurist. Within the sector external care there are possibilities for a transfer to, for instance, Beauty care, the qualification All-round beautician (level 4).</p>	<p><b>International agreements</b></p> <p>The profession of Pedicurist is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b></p> <p>Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25406</p> <p>The education and training for this qualification is offered as of August 1, 2015.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b></p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

## 7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
