## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round concrete repairman are:

Core task 1: Repairs concrete

- 1.1 Checks materials and resources
- 1.2 Organises the workplace
- 1.3 Prepares the ground
- 1.4 Repairs concrete manually
- 1.5 Applies pouring concrete
- 1.6 Injects parts of buildings
- 1.7 Applies protection layer
- 1.8 Clears up the workplace

Core task 2: Organises daily tasks of colleagues

- 2.1 Divides up working duties and supervises colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Consults and agrees with third parties
- 2.4 Monitors the progress
- 2.5 Reports to supervisor

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round concrete repairman works within the concrete repair branch of industry. He works in civil & utility construction and road & hydraulic construction. He works in both private and large construction projects. He carries out all concrete repair tasks, including complex ones, both constructive as non-constructive.

<p><b>Access to next level of education/professions</b> An All-round concrete repairman diploma provides access to VET-level 4, such as qualifications within the qualification file Planning/implementation. Through training or education at the workplace, an All-round concrete repairman can specialise in certain types of concrete repair tasks. After supplemental education(s) and in case of indicated competences, an All-round concrete repairman can develop to higher functions within the concrete repair sector, such as foreman, construction supervisor, planner, calculator or manager.</p>	<p><b>International agreements</b> The profession of All-round concrete repairman is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25079 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

## 7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
