## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled commercial vehicle mechanic are:

- to carry out inspections and provide service;
- overhaul/ 24 hours service;
- to diagnose the case;
- to repair defects and correction breakdowns;
- the delivery of heavy cars.

Required competences are:

- systematic working;
- controlling systems and parts;
- analyzing data;
- forming opinions (to have judgment skills);
- taking care of a quality customer and service orientation;
- to be cost-conscious;
- mouth and written communication skills;
- empathy;
- accompaniment and development skills;
- to be able to build up expertise.

- Skilled commercial vehicle mechanic;
- Master technician.

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. <p><b>Access to next level of education/professions</b> With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.</p>	<p><b>International agreements</b> The profession of Skilled commercial vehicle mechanic is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
