- 1.4 Makes a presentation plan
- 1.5 Contributes to the treatment and/or processing process

Core task 2: Guides and coaches the company

- 2.1 Determines staff planning
- 2.2 Familiarises oneself in the hiring of/having staff
- 2.3 Supervises colleagues
- 2.4 Organises and holds work meeting
- 2.5 Maintains contact with third parties

Core task 3: Determines and carries out financial policy and marketing strategy

- 3.1 Determines financial policy and monitors financial situation
- 3.2 Determines marketing policy and makes choices
- 3.3 Carries out accounting tasks and accountability
- 3.4 Takes preventive measures against shop crimes

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Entrepreneur fresh produce works in special fresh product shops or departments selling fresh produce such as the artisanal butcher, the sausage makers, fresh produce of a supermarket, fish speciality shops, speciality shops selling potatoes, vegetables and fruit, the poulterer or shops selling game. The specific context in which the Entrepreneur fresh produce is working in, determines with which guidelines he has to deal with promoting food

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years 4800 (study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
