## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled gardener/green spaces worker are:

Core task 1: Lays out nature and living environment

- 1.1 Prepares the grounds for lay-out work
- 1.2 Carries out earth-moving
- 1.3 Lays sewage and/or water drainage systems
- 1.4 Provides water supply (and water features)
- 1.5 Makes hardened areas
- 1.6 Places constructional elements
- 1.7 Lays technical provisions
- 1.8 Plants green provisions
- 1.9 Completes the construction work

Core task 2: Maintains nature and living environment

- 2.1 Carries out control of weeds, diseases and plagues
- 2.2 Carries out soil improvement
- 2.3 Maintains sewage and/or water drainage systems
- 2.4 Maintains water (features)
- 2.5 Maintains hardened areas
- 2.6 Maintains constructional elements
- 2.7 Maintains technical provisions
- 2.8 Maintains green provisions
- 2.9 Leaves work environment well-kept

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled gardener/green spaces worker works in a gardening company, a green spaces company, a tree care company or a company that combines all these activities.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
