Access to next level of education/professions The Assistant logistics worker can in principle enter all study courses at level 2. The Assistant logistics worker wishing to progress in the same field can advance to the level of basic professional practitioner as general or specialist logistic worker in a particular sector (for example the timber trade). Other opportunities for advancement are to the level of basic professional practitioner as warehouse worker, delivery service worker, driver in goods transport or port logistics worker. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	1 year (1600 study hours) (depending on previous education)
Entry requirements There are no legal educational requirements.	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
