The most important duties of a Ship and yacht builder are:

Core task 1: Prepares the building/ repair of boat

- 1.1 Gathers together and screens information for the basic design
- 1.2 Puts together the basic design
- 1.3 Makes work and construction drawings
- 1.4 Collaborates in making up the contract
- 1.5 Makes up quotations

Core task 2: Assists in project management of the building process

- 2.1 Starts up the engineering phase
- 2.2 Selects suppliers and subcontractors
- 2.3 Organises and orders the necessary materials, machinery and tools
- 2.4 Monitors the budgets
- 2.5 Monitors the progress
- 2.6 Administers and reports about the data of the project
- 2.7 Determines the final calculation and recalculations
- 2.8 Prepares for delivery of the boat
- 2.9 Maintains contacts

Core task 3: Supervises the colleagues on the workfloor

- 3.1 Plans and divides up the working duties
- 3.2 Manages colleagues
- 3.3 Monitors the teamwork
- 3.4 Advises the contractors

Core task 4: Works on the building/ repair of boat

- 4.1 Carries out building and repair working duties
- Inspects materials, parts and goods
- Measures and inspects (intermediate) products

## The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education. Culture and Science pupil attended the programme.

## Level of the certificate (national or international)

Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

#### Access to next level of education/professions

After additional training and proven competencies, the Ship and yacht builder can rise to the position of project leader. He can do a relevant programme in higher vocational education (hbo).

### International agreements

The profession of Ship and yacht builder is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93080 The education and training for this qualification is offered as of August 1, 2009.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## Average duration of the education/ training leading to the certificate

4 year(s) (6400 study hours) (depending on previous education)

#### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
