#### 3. PROFILE OF SKILLS AND COMPETENCES

The core tasks of a Personal care provider specific target groups are:

Core duty 1: Draws up a support plan

- 1.1 Lists help needs of the client
- 1.2 Draws up the support plan
- 1.3 Specifies the support plan to become an activity plan

Core duty 2: Offers supportive, activating assistance and care

- 2.1 Supports the client with the personal hygiene
- 2.2 Supports the client with living and housekeeping
- 2.3 Supports the client with the way he spends his day
- 2.5 Supports the client to direct his own life
- 2.6 Supports the social system

Core duty 3: Performs organization and profession-related duties

- 3.1 Works on professional advancement and professionalization
- 3.2 Works on the improvement and monitoring of quality care
- 3.3 Negotiates the work with the stakeholders
- 3.4 Carries out coordinating tasks
- 3.5 Evaluates the offered support

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Personal care provider specific target groups can for example be employed as a counsellor in a residential group at an addiction clinic, at a facility for the homeless, women's shelter or in a psychiatric clinic. The Personal care provider specific target groups may also be employed as a counsellor in an activities centre for day care, a welfare institution, a social work facility, a penitentiary facility, a nursing home, a care home or an asylum-seekers' centre. He will with increasing regularity come into contact with clients with a psychiatric disorder, beyond the

Access to next level of education/professions Having obtained the certificate Personal care provider specific target groups, transfer is possible to higher professional education (HBO) programmes, for example the study programme Social Pedagogic Care or Nursing or the study programme Practical trainer.  Legal basis	International agreements The profession of Personal care provider specific target groups is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92662 The education and training for this qualification is offered as of August 1, 2010.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
