## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor land survey performs his work on the one hand before, during and after the realization of construction and infra projects; and on the other hand on behalf of the Legal situation, purpose and use of the space. Mostly employed by specialized firms, public authorities or large contractors.

<p>Qualification level 4 of the Dutch VET qualification structure</p> <p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. <p><b>Access to next level of education/professions</b></p> <p>Having completed this course of studies, transfer is possible to higher professional education.</p> <p>The Supervisor land survey can develop into an employee with more responsibilities who manages larger and/or more complex projects. The Supervisor land survey can further specialize from almost all functions with corresponding general or specific schooling or develop into managerial functions with greater responsibilities. Educational possibilities for that purpose are: related hbo programmes, Geodesy, Geo-informatics or Environmental planning.</p>	<p><b>International agreements</b></p> <p>The profession of Supervisor land survey is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 year(s) (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b></p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
