# 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Crane truck operator are:

- Safe equipping of the construction site and the erection and/or setting of the crane;
- Carrying out the required inspections and preparatory tasks for the use of the machine and auxiliary equipment including (starter) batteries, low-voltage generators, drive mechanisms and other components of the crane;
- Operating the crane, taking account of the lifting capacity and moment of load, as necessary using arm signals and telephone and radio communication equipment;
- Picking up the loads to be transported using the relevant hoisting gear, including chains, hoisting strops, etc. and hoisting, transporting and depositing the loads;
- Securing the crane or hoisting installation during and after working hours, taking account of the circumstances on the construction site and weather conditions:
- Assisting in the disassembly and transport of the crane and/or the safe storage of the crane;
- According to regulations, carrying out all required cleaning and maintenance work on the crane and the accompanying equipment, devices and tools:
- Identifying any technical shortcomings and as necessary assisting in inspection and repair work:
- Registering technical specifications and reporting the progress and results of the work.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
