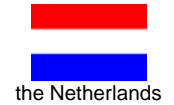

3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Mechanic low voltage networks are:

The Mechanic low voltage networks works on distribution networks via which houses, businesses and factories are supplied with low voltage electrical power. Low voltage networks are networks with an electrical voltage of up to 230/400 volt. Other networks on which the mechanic may work include public lighting or traffic installations. Work is generally carried out on the installation and maintenance of these (underground) networks. The work includes connecting various domestic and commercial installations to the network supplied by the power companies. It is important to work in accordance with the NEN 1010 standard; this is the official standard that describes how electrical installations must be installed and calculated safety and correctly.

The study programme consists of 4 compulsory elements:

- Compiling and connecting network components, low voltage
- Laying a low voltage cable network
- Safe working and measuring in electrical engineering
- Social and cultural education level 2

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	2 years (3200 study hours) (depending on previous education)
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
