Core task 2: Plans, coordinates and monitors the logistics process

- 2.1 Plans and monitors the flow of goods
- 2.2 Maintains and manages the flow of documents
- 2.3 Inspects special deliveries
- 2.4 Measures, compares and reports results in the logistics process
- 2.5 Makes suggestions for and implements improvements concerning the logistics process
- 2.6 Provides functional leadership

Core task 3: Plans and manages transport

- 3.1 Takes on transport assignments
- 3.2 Formulates transport plans and manages transport equipment
- 3.3 Is responsible for documents and carries out the administration
- 3.4 Monitors the transport remotely

<p>Access to next level of education/professions The Aviation logistics provider can be promoted to higher managerial positions within aviation logistics, such as the logistics manager. The aviation logistics assistant can enter the higher vocational education programme for Logistics and economics at the Hogeschool van Amsterdam or InHolland.</p>	<p>International agreements The profession of Aviation logistics provider is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91860 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
