### 3. Profile of skills and competences

The most important duties of a Jewellers' employee are:

Core task 1: Manages and presents the assortment at the jewellers'

- 1.1 Processes ordered jewellers' articles
- 1.2 Inspects stock and makes suggestions about stock policy
- 1.3 Makes suggestions about purchasing policy
- 1.4 Builds up presentations of jewellery articles
- 1.5 Sets up and puts away articles at jewellers' on a daily basis

Core task 2: Sells and advises

- 2.1 Sells jewellery articles
- 2.2 Receives and deals with complaints
- 2.3 Completes sales and advice
- 2.4 Prevents crime

Core task 3: Takes care of repair work

- 3.1 Advises about repairs
- 3.2 Registers repairs and determines who should carry out the repair
- 3.3 Carries out repairs

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Jeweller's sector mainly consists of self-employed entrepreneurs in the retail trade. The Jeweller's employee works in employment for an independent jeweller's or chain companies.

### 5. OFFICIAL BASIS OF THE CERTIFICATE

# Qualification level 3 of the Dutch VET qualification structure

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. ## Access to next level of education/professions

The Jeweller's employee can do the Jeweller's programme level 4. There are several career opportunities for the Jeweller's employee within the chain store and the wholesaler's, such as (assistant) business manager. In addition, he can develop further within the trade by specializing, for instance in more administrative tasks.

## International agreements

The profession of Jeweller's employee is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92810 The education and training for this qualification is offered as of August 1, 2009.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
