3. PROFILE OF SKILLS AND COMPETENCES
<p>The most important duties of a Manager horse farm are:</p> <p>The Manager horse farm is responsible for the general management of the business. With that in mind, he/she carries out activities relating to management, supervision and control of all work undertaken by the staff, and he/she takes independent decisions.</p> <p>The Manager horse farm also carries out operational tasks and trains and cares for horses. The Manager horse farm also monitors the breeding of horses and he/she periodically organises events.</p>

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
Manager, equestrian entrepreneur or manager horse farm.

<p><b>Access to next level of education/professions</b> With a diploma at qualification level 4, transfer is possible to higher professional education.</p>	<p><b>International agreements</b> The profession of Manager horse farm is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b> Adult and Vocational Education Act (WEB), registered number of qualification (crebo): 11035</p>	

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 year(s) (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
