3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of Junior navy personnel are:

Core task 1: Preserves a position in an environment considered 'safe' for militaries

- 1.1 Prepares a military assignment
- 1.2 Makes and keeps him/herself ready for deployment
- 1.3 Prepares and maintains their equipment and material ready for deployment
- 1.4 Contributes to the security of the safe location
- 1.5 Acts with decision during incidents and calamities
- 1.6 Evaluates his/her performance

Core task 2: Carries out coordinating duties

- 2.1 Informs the team members about the plan
- 2.2 Gives directions to the team members

Core task 3: Carries out nautical and general ship duties

- 3.1 Assists the loading and unloading of goods
- 3.2 Assists to make vessel and crew ready for deployment
- 3.3 Assists with mooring and anchoring of a maritime unit
- 3.4 Sails small vessels
- 3.5 Carries out activities for bridge- and command centre
- 3.6 Receives and dispatches messages through military or civilian speech connections

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

As a future sailor in training, Junior navy personnel learns to carry out operational service tasks on board a maritime unit (Naval ship). He learns what it means to be battle ready. In that role, he learns to carry out nautical and general ship-related tasks as member of a team. This includes assisting in mooring, slipping mooring and anchoring the maritime unit, loading and unloading equipment. He is able to operate the small crane for lifting and

Access to next level of education/professions The study course Junior navy personnel prepares for a career in the Defence organisation. Junior navy personnel generally transfer to the Royal Dutch Navy, following training. Following appointment, part of general basic training must still be completed. Junior navy personnel generally start with naval training, following appointment. Positions in which Junior navy personnel can end up are very diverse, from operational positions through to technical or logistic positions. He starts his career at the rank of senior recruit. Junior navy personnel can progress to the study course Junior officer at level 3, the study course Security coordinator (he must first have obtained the certificate Security officer at level 2) or the study course Enforcer surveillance and security. Internal transfer within the Defence organisation to Junior officer level 3 is possible via previously acquired competences and (additional) training, and is encouraged by the Defence organisation. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the
