The most important duties of a Skilled mechanic heavy current installations are:

- Installation of cable installations in home, commercial and industrial building;
- Assembly, wiring and installation of switching and distribution devices in home, commercial and industrial buildina:
- Contributing to and supervising the installation of electrical installations in home, commercial and industrial building:
- The maintenance of electrical installations in home, commercial and industrial building;
- Commissioning of and fault tracing in electrical installations in home, commercial and industrial building. A Skilled mechanic heavy current installations is responsible for the execution of tasks: applying and combining of standard procedures and devising of procedures. A Skilled mechanic heavy current installations controls and supervises the application of automated routines and standard procedures by others, and bears hierarchical responsibility for this.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**
