3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Engraver/entrepreneur are:

- Machine 3D relief engraving
- Machine 2D face engraving
- Relief and line engraving

In addition to professional training for engravers, the study programme also includes general entrepreneurial skills for starting your own business. The professional training includes hand engraving, machine engraving, relief engraving, tool making and the use of photographic processes in engraving.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Engraver/entrepreneur works as an Engraver/entrepreneur for an engraving company, at an engraving facility and in the engraving industry, or as a department head at an engraving department in the fine mechanical engineering sector.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
