- 1.5 Delivers glazing work

Core task 2: Carries out glazing fittings

- 2.1 Prepares to do glazing fittings
- 2.2 Assembles glazing systems

Core task 3: Carries out practical project management

- 3.1 Prepares the project
- 3.2 Manages colleagues
- 3.3 Coaches students/new employees
- 3.4 Monitors quality and progress of project
- 3.5 Delivers the project

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Journeyman glazier is usually employed or works independently in glazing companies or the glass damage repair sector. He carries out his tasks for various clients within both the residential and utility buildings, such as houses offices and hospitals. This can involve both maintenance and construction.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25005

The education and training for this qualification is offered as of August 1, 2015.

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
