- 4.1 Works on one's own expertise
- 4.2 Works on the improvement and assurance of quality care
- 4.3 Works in multidisciplinary team and coordinates work activities
- 4.4 Coaches new colleagues, apprentices and/or volunteers

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Doctor's assistant can work in various kinds of organisations, such as (solo and group) general practice, family doctor's practice, (outpatients') clinic, social healthcare, health centre, youth healthcare, blood transfusion service, laboratory and medical service.

<p>Access to next level of education/professions The Doctor's assistant can be exempted from courses from different VET level 4 educations, such as Dental nurse or Nurse (general care). The Doctor's assistant can develop through higher professional educations such as Practice support or Practice manager. After 2 years of experience in general practice or similar work, a Doctor's assistant can work as a triagist after getting the Triagist diploma (through InEen). It is especially possible to develop to functions such as medical aid (on higher professional education level) at a surgery, x-ray department and emergency ward, and to nurse (higher professional education).</p>	<p>International agreements The profession of Doctor's assistant is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
