- 1.4 Makes quotations for products and/or services
- 1.5 Carries out recalculations of the working duties

Core task 2: Prepares and monitors the implementation of the work

- 2.1 Organises and plans the implementation process
- 2.2 Monitors and inspects the progress
- 2.3 Monitors and inspects the quality
- 2.4 Monitors the budgets
- 2.5 Is responsible for and communicates project information
- 2.6 Formulates quality, working conditions and the environment policies

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor planning and calculation works in various market segments, such as new construction, renovation, maintenance, and repair. The products and services are supplied to contractors, housing associations, (semi) government agencies, business clients, and private persons.

<p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures. <p><b>Access to next level of education/professions</b> Within the own organization, the Supervisor planning and calculation can be promoted to a position with more responsibility for projects/works/assignments.</p> <p>Possibilities for education are: related higher vocational education programmes for Structural engineer, Civil engineer, Structural management.</p>	<p><b>International agreements</b> The profession of Supervisor planning and calculation is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93871 The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
