- 3.3 Implements an application or (cross)media presentation and/or system
- 3.4 Evaluates an implementation

Core task 4: Maintaining and managing the application, (cross)media presentation or game

- 4.1 Maintains applications or (cross)media presentation
- 4.2 Manages the content
- 4.3 Documents and archives (data regarding) applications

<p>Access to next level of education/professions The Application developer can move on to a broader function, such as ICT manager. Via schooling or work experience he can grow into a function as application developer, programmer or application manager at the level of higher vocational education.</p>	<p>International agreements The profession of Application developer is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95311 The education and training for this qualification is offered as of August 1, 2011.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
