3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round assembler industrial wood production are:

Core task 1: Assembles wood elements

- 1.1 Prepares assembly of wood elements
- 1.2 Selects, monitors and transports materials
- 1.3 Compiles wood elements
- 1.4 Assembles wood elements
- 1.5 Prepares wood elements for shipping
- 1.6 Completes assignment of assembling wood elements

Core task 2: Works on wood/plates for wood elements, using machinery and tools

- 2.1 Does preparatory work for activities with machines and tools
- 2.2 Selects, monitors and transports wood and sheet material
- 2.3 Sets up and adjusts cutting tools of machines and tools
- 2.4 Adjusts machines and tools
- 2.5 Carries out test runs with machines and tools
- 2.6 Performs operations with machines and tools
- 2.7 Completes assignment processing wood and plate material

Core task 3: Supervise production process of wood elements

- 3.1 Coaches and instructs all-round assembler industrial wood production
- 3.2 Monitors production process wood elements

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round assembler industrial wood production works at a company aimed at industrial production of wood elements. He works on both standard and non-standard wood elements, such as special facade elements or elements of special timber frame constructions.

<p>Access to next level of education/professions The most obvious course of development for the All-round assembler industrial wood production is Technical manager or Planner industrial wood production, which are both VET-level 4.</p>	<p>International agreements The profession of All-round assembler industrial wood production is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25007 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
