### 3. Profile of skills and competences

The most important duties of a Transport driver are:

Core task 1: Transporting cargo by truck

- 1.1 Carries out journey preparation
- 1.2 Distributes the load and secures the load
- 1.3 Is responsible for documents
- 1.4 Deals with incidents / accidents
- 1.5 Manoeuvres the truck
- 1.6 Participates professionally in traffic
- 1.7 Carries out daily inspections
- 1.8 Carries out minor repairs
- 1.9 Couples and decouples truck combinations
- 1.10 Plans and calculates driving and rest times
- 1.11 Assesses the condition and volume of the load
- 1.12 Loads and unloads the cargo

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Transport driver is employed by a transport company, a driver operator or other business with a transport department. His place of work is the truck in all possible variants and designs (combinations of vehicles including trailers and semi-trailers, load carriers such as set-down containers and goods containers). With his truck, he transports any cargo between multiple, possibly changing loading and unloading points in the Netherlands and/or throughout Eurasia and North Africa.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate	2 years (3200 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
