The most important duties of a Bricklayer are:

- facing brickwork;
- brickwork for rendering;
- gluing work and producing lightweight dividing walls;
- carry out gluing work elements and blocks;
- pointing work.

The Bricklayer is qualified to independently or subject to the supervision of a foreman or assistant building supervisor, the most common work processes in civilian and industrial construction and can be broadly deployed in the sector.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Bricklayer is employed by a contractor of specialist bricklaying company. The Bricklayer may be employed in new building, extension or renovation work, or in the restoration sector.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
