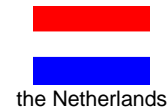

The Advisor sustainable living environment is employed in public space and/or at companies active in/with the sustainable living environment. This includes water, power, food supply and leisure activities in the sustainable living environment.

<p>Access to next level of education/professions A qualified Advisor sustainable living environment can transfer to higher professional education such as Management of the living environment at the HAS, Sustainable water technology and Management of the living environment at Van Hall-Larenstein and International Lifestyle at Fontys. During the course of study, he can also specialise in a particular field, via elective subjects.</p>	<p>International agreements The profession of Advisor sustainable living environment is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Adult and Vocational Education Act (WEB), registered number of qualification (crebo): 26009</p> <p>The cross-over qualification may only be offered by the educational institution if it has received a decision from the Minister of Education, Culture and Sciences permitting it to offer the cross-over qualification.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
