#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Hairdresser-entrepreneur are:

Core task 1: Cuts and razor cuts the hair

- 1.3 Cares for the hair and the scalp
- 1.4 Cuts and razor cuts

Core task 2: Styles hair

- 2.1 Makes up or adjusts a treatment plan and prepares treatment
- 2.2 Cutting long hair
- 2.3 Blow-drying and styling
- 2.4 Temporary styling
- 2.5 Permanent styling
- 2.6 Selling and advising about products and services

Core task 3: Colours and bleaches hair

- 3.1 Makes up or adjusts a treatment plan and prepares treatment
- 3.2 Colours and bleaches hair
- 3.3 Completes treatment and brings administration up-to-date

Core task 4: Setting up a hairdresser salon

- 4.1 Analysing the market
- 4.2 Shaping a hairdresser salong
- 4.3 Taking care of the financial part of the hairdresser salon
- 4.4 Purchasing and monitoring the stock
- 4.5 Carrying out staff policy

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Hairdresser-entrepreneur is as a manager or owner entrepreneur employed in one or more hairdresser salons. Salons such as specialised women hairdressing salon, a specialist men hairdressing salon, a combined hairdresser salon or a specific hairdresser salon. The last type of salon could be, for instance, a budget salon or a salon that focuses on fashion-minded and trendy customer group. Most hairdresser salons are combined salons, which means that they focus on both women and men and mostly children as well.

Access to next level of education/professions The Hairdresser-entrepreneur can continue to grow to an entrepreneur with several hairdresser salons/establishments, or to positions in adjoining companies such as manufacturers of hair care products or of aids for the hairdresser or hairdresser salon. The Hairdresser-entrepreneur can transfer to several courses in hbo in the field of entrepreneurship and management, for instance, to courses such as Small business, Business administration, Management, economics and law (MER) or (Commercial) Economics	International agreements The profession of Hairdresser-entrepreneur is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95742 The education and training for this qualification is offered as of August 1, 2012.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
